Definition of Key Terms	
Demurrage Free Time	Start counting from the next day of gate-in to MOL's facility(Excluding gate-in date, Sundays and holidays during the period of free time are excepted).
Demurrage Charge	Demurrage charge will be accumulated immediately after the free time expires. The charge shall be settled with MOL.
Detention Free Time	Start counting from the next day of released by carrier. (Excluding released date. Sundays and holidays during the period of free time are excepted)
Detention Charge	Detention charge will be accumulated immediately after the free time expires. The charge shall be settled with MOL.
